## CONTRIBUTORS

**Krishna P. Adhikari** is a Research Fellow at the Institute of Social and Cultural Anthropology, University of Oxford, and was Co-Investigator of the ESRC-funded project ‘Caste, Class, and Culture: Changing Bahun and Dalit Identities in Nepal’ (2013–17). After twelve years as a practitioner and manager in the field of rural development, he did a PhD at the University of Reading (2007) on the dynamics of social capital and community institutions. He edited *Nepalis in the United Kingdom: An Overview*, published by Centre for Nepal Studies UK, in 2012.

**Tilak Biswakarma** is a Lecturer in Sociology at Tribhuvan University, Nepal and serves at Ratna Rajya Laxmi Campus. He has an M.Phil. in Sociology from Tribhuvan University and is probably the first Dalit to be a permanent lecturer of sociology in the history of T.U. He has also worked in the fields of youth and peace, the rights of marginalized groups, and poverty alleviation. Similarly, he has been working continuously in the field of development, research, and education for more than a decade. He has published a number of articles on different Dalit-related issues. His areas of expertise include Dalits’ caste-based occupations, inter-caste marriage, and Dalit citizenship and social security.

**Arjun Bahadur BK** is a social science researcher, education practitioner, and an emerging Dalit scholar. Academically from a humanities background, he later entered the social sciences as a student of Nepa School of Social Science and Humanities in 2011. He joined as a research officer and accomplished sixteen months of fieldwork in west Nepal as part of the Oxford University ESRC-funded ‘Caste, Class and Culture’ project. His areas of interest are Dalit movements, social exclusion/inclusion, discourse, identity politics and Dalit aesthetics, and Dalit representation.

**Steve Folmar** is Associate Professor and Chair of the Anthropology Department at Wake Forest University. For nearly two decades he has focused on a variety of

issues related to Dalits in the middle hills of Nepal, most recently examining how status as a Dalit affects mental health and how that relationship was affected by the 2015 earthquakes.

**David N. Gellner** is Professor of Social Anthropology and a Fellow of All Souls College in the University of Oxford. Four of his many edited volumes, *Borderland Lives in Northern South Asia* (Duke), *Religion, Secularism, and Ethnicity in Contemporary Nepal* (OUP), *Global Nepalis: Religion, Culture, and Community in a New and Old Diaspora* (OUP), and *Vernacular Religion: Cultural Politics, Community Belonging, and Personal Practice in the UK's Nepali Diaspora* (Vajra/CNSUK), appeared in 2013, 2016, 2018, and 2019 respectively. He has worked on religion, politics, ethnicity, and social change in Nepal since 1981 and was Principal Investigator of the 'Class, Caste, and Culture' project.

**Sambriddhi Kharel** is a sociologist and researcher based in Kathmandu. She holds a PhD in Sociology from the University of Pittsburgh, Pennsylvania. Her dissertation examined the 'The Dialectics of Identity and Resistance among Dalits in Nepal.' Her research interests lie in understanding social inequalities through the intersectionality paradigm, i.e. the dynamic interaction of caste, class, race, ethnicity, gender, and region. Her most recent research examines the enabling and constraining factors in translating the 2030 (SDG) Agenda from a gender equality and empowerment perspective. She is also undertaking research focused on the working conditions and agency of women construction workers in Nepal.

**Joanna Pfaff-Czarnecka** is professor of social anthropology in the Faculty of Sociology, Bielefeld University, Germany. She currently acts as Co-Director of the ZiF, the Center for Interdisciplinary Research at Bielefeld University. She is Dean of her Faculty and a Senate member of the German Research Foundation. Her research focuses on ethnicity, inequality, democratization processes at the sub-national level, on belonging as well as on the 'social life' (especially the nexus of inequality and heterogeneity) of universities in Germany and in South Asia. Among her publications are: 'Spaces of Violence in South Asian Democracies' (special issue of the *Asian Journal of Social Science* 45(6), 2017); *Facing Globalization in the Himalayas: Belonging and the Politics of the Self* (ed. with G. Toffin, Sage, 2014); and 'Ethnic Futures', written together with A. Nandy, D. Rajasingham, and T. Gomez (Sage, 1999).

**Krishna Shrestha** is Associate Professor at the School of Social Sciences, University of New South Wales, Australia. His research program is in the interdisciplinary analysis of Social and Environmental Justice, focusing on the intersection of development and environmental planning, policy, and management. Over the years his research projects have encompassed four key areas: (a) political ecology and international development, (b) climate change adaptation and urban planning, (c) food security and livelihoods, and (d) disaster resilience and justice.

**Manoj Suji** holds a Master's in Anthropology in 2015 from Tribhuvan University, Nepal. He is Research Associate at Social Science Baha and currently involved in the 'Expertise, Labour and Mobility in Nepal's Post-Conflict, Post-Disaster Reconstruction' research project with the University of British Columbia, Canada (<https://elmnr.arts.ubc.ca/>). He has been involved in several research projects that focused on post-earthquake recovery, reconstruction, infrastructure development, community forest governance, gender, social inclusion, minority, migration and foreign employment. His research interests include natural disasters, disaster preparedness, disaster risk reduction, post-disaster recovery and reconstruction, social inequality, gender, caste/ethnicity, and minorities.

**Ramesh Sunam** is Assistant Professor at the Waseda Institute for Advanced Study, Waseda University, Tokyo, Japan. His research focuses on international migration, rural poverty, food security, and human dimensions of environmental change. He has published several papers in leading international journals such as the *Journal of Peasant Studies*, *Anthropological Forum*, the *Journal of Ethnic and Migration Studies*, and *Society and Natural Resources*. Ramesh earned his PhD from the Australian National University in 2015.
